**To Whom It May Concern:**

I (or read "we" if applicable throughout this Agreement) agree to ride at Linda Kerr's residence (also called "Country Lane Stables"), with or without instructor, or ride with the Kerr's at other locations, or to be trailered by Linda Kerr's (or any agent working or helping out on Linda Kerr's behalf) to other locations, or be around and with the horses, whether working with (paid workers are covered by Workers Compensation) or attending to them and activities, and that I will not be waned about specific risks, danger or hazards. I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury or death to either humans or horses, property damage or loss resulting therefrom.

I will hold harmless and indemnify Linda Kerr, Country Lane Stables, their workers or volunteers, any instructor their assigns or heirs, from any and all liability for any property damages or personal injury to any third party, resulting from my activities.

It is my (or read "our" if applicable through out this Agreement) responsibility to ensure that all the listed people or any of my guests, whether they are riding or watching or attending to horses, are under competent adult supervision or, failing that, I will provide supervision at all times. It is not Country Lane Stable's intention or responsibility to provide any supervision at all.

County Lane Stables does not investigate or recommend any riding instructors as to abilities, certification, competence or suitability to your level of riding. The instructors who come here are coming for the convenience of other students, and if you wish to ride with any particular instructor, you make the arrangements directly with the instructor. County Lane Stables does not receive any income or consideration from the instructors.

I will provide and ensure that all required equipment, whether belonging to me (us) or rented or leased (whether it is protective or general horse tack) is in good repair and is used at all times properly. If I, as an adult, choose not to use any or all protective equipment, including the use of and approved, protective riding helmet (hard hat), I do so at my own risk, fully knowing that it is not recommended by Country Lanes Stables, Linda Kerr and, and I assume all responsibility for my decision not to wear protective equipment. Minors must wear all protective equipment, including an approved protective riding helmet (hard hat), that is usual and customary for the activity that they are riding in.

**The undersigned owner, parent, guardian, handler, spectator, rider, instructor, and their respective heirs, next of kin, executors, and assigns, hereby acknowledges and agrees to accept all risks and/or negligence, and waive any claims for personal injury or any loss incurred, against Linda Kerr, Country Lane Stables, their workers or volunteers, any instructor, their assigns, or heirs, that may arise as a result of participation in any equestrian event, or any general activity at Linda Kerr's residence (Country Lane Stables), or with Linda Kerr at other locations, or while being trailered by Linda Kerr, (or any agent working or helping out on their behalf) to other locations**

**This agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, and assigns in the event of my death.**

**Prior to signing, I have read and understand this Agreement, and I am aware that by signing this Agreement, I am waiving certain rights which I, my minor children, my heirs, next of kin, executors, administrators and assigns may have against Linda Kerr, Country Lane Stables, their workers or volunteers or any agent working or helping out on their behalf or any instructor, their assigns, or heirs.**
